A. Budget Review and Adoption

Property Tax Report Card

RESOLVED, that the Board of Education hereby adopts the proposed budget for the 2018-2019 school year, in the total amount of \$135,686,223 for presentation to the public at a public hearing on Wednesday, May 2, 2018 at 8:30PM in the Board Room of the Administration Building, and for submission to the qualified voters of the Hicksville Union Free School District for approval on Tuesday, May 15, 2018 between the hours of 7:00AM and 9:00PM, prevailing time; and

IT IS FURTHER RESOLVED, that the Board of Education hereby adopts and approves the Property Tax Report Card, appended to the adopted proposed budget, and directs the District Clerk to transmit said Property Tax Report Card to the State Education Department by the end of the next business day; and

IT IS FURTHER RESOLVED, that the Board of Education directs the District Clerk to include aforesaid total amount in the School Budget Notice that will be mailed to all qualified voters of the Hicksville Union Free School District after the date of the Public Budget Hearing, but no later than six (6) days prior to the Annual Meeting, Budget Vote and Election.

RESOLUTION

RESOLVED, upon the recommendation of the Superintendent of Schools, the Board of Education hereby authorizes the placement of the following propositions at the Annual Budget Vote and Election on May 15, 2018, and directs the District Clerk to place said propositions in the Annual Notice of said Vote and Election and ratifies the placement of such proposition in any Annual Notice of said Vote and Election heretofore published:

Proposition No. 1

Shall the School District Budget, in the amount of \$135,686,223 pursuant to Education Law Section 1716, be approved, and a tax on the taxable property of the District in the amount of such Budget, less State and Federal Aid and revenues from other sources, be levied?

Proposition No. 2

In the event the voters approve the School Budget contained in proposition 1, shall the Board of Education be authorized to establish the District-wide Technology Capital Reserve Fund ("Fund") effective June 30, 2018, in the ultimate amount of \$1,721,030, plus interest accruals, for the purpose of security upgrades and technology projects at various school buildings, Capital improvements to the facilities of the District including, but not limited to, additions and upgrades to security and technology including surveillance cameras, door access controls, digital video recorders, door swipes, man traps, door hardening, upgrades to network security infrastructure, elementary school WiFi, audio/video system for small theater in high school, attendance and visitor management systems, classroom technology, and ancillary or related work required in connection therewith, for a probable term of three (3) years, funded by a transfer of \$1,000,000 of unexpended surplus from the Workers Compensation Reserve and \$721,030 from the Unemployment Reserve, thereby incurring no additional cost to the taxpayer in the 2018-19 school year, to undertake commencing with the 2018-2019 school year the following projects consisting of additions and upgrades to security and technology including surveillance cameras, door access controls, digital video recorders, door swipes, man traps, door hardening, upgrades to network security infrastructure, elementary school WiFi, audio/video system for small theater in high school, attendance and visitor management systems, classroom technology, and ancillary or related work required in connection therewith, and to expend therefor commencing with the 2018-2019 school year an amount not to exceed the estimated aggregate maximum cost of \$1,721,030, plus interest accruals, provided that the detailed costs of the components of the projects as set forth herein may be reallocated among such components if the Board of Education shall determine that such reallocation is in the best interests of the District provided; however, that the aggregate amount to be expended shall not exceed the \$1,721,030, plus interested accruals, estimated aggregated maximum cost of the projects and that no material change shall be made in the scope of the projects?

This PROPOSITION is contingent upon approval of the voters of PROPOSITION NO. 1

Proposition No. 3

In the event the voters approve the District Budget contained at PROPOSITION NO. 1 above, shall the sum of \$60,000 be appropriated to the Hicksville Gregory Museum for educational services associated with its programs and a tax be levied on the taxable property of the District in that amount?
